



Adoption Agreement

1. I intend to provide the adopted animal with a lifelong loving home, in my home, with proper food, shelter and water available at all times. I am not adopting this animal as a gift for anyone else.
2. I agree to keep the cat in my home at all times and not transfer it to any other party. In my home it will be held securely indoors, with screens in any windows that are ever opened (either bottom or top), and without access to back yards, balconies, terraces, fire escapes, rooftops or public hallways.
3. **I will not abandon or give up the animal to any shelter or laboratory. If I am unable to keep the animal for any reason, I will notify Whiskers-a-GoGo, ("WaGG"),** making every effort to keep it for a reasonable amount of time until WaGG finds it a new home or foster care.
4. I agree not to give the adopted animal to any other individual, including family members, without the prior written permission of WaGG understand that the animal may take a period of time to adjust to its new surroundings. I will notify WaGG of any adjustment difficulties and ask for assistance if there are problems.
5. To the best of my ability, I will provide for my companion animal's future security by informing those closest to me of the presence of the cat in my home and of the fact that WaGG should be contacted immediately in the event of any emergency that makes it impossible for me to keep or provide for the cat.
6. If the animal is lost, I will make every effort to recover it. I notify WaGG immediately, make a report to the city's Lost & Found database (311), and post signs at local veterinary offices and around the neighborhood.
7. I will provide the animal with all necessary medical care, including check-ups and veterinary care for any unusual symptoms such as sneezing, coughing, runny eyes, weight loss, hair loss, scratching, vomiting, lethargy, diarrhea, loss of appetite, blood in stool, straining in the litter pan, urinating outside the litter box, etc. I will notify WaGG of any medical problems with my newly adopted pet.
8. I will not declaw the adopted cat.
9. I will not allow the adopted animal to reproduce.
10. WaGG will not be held liable for any medical costs after adoption, nor for damage or injury to persons, property, or other animals which may be caused by the adopted animal.
11. *Willful misrepresentation of personal and household information, or failure to abide by my commitments under this agreement, or any other mistreatment of the adopted animal, shall constitute a violation of this contract and the animal shall be returned upon demand. Failure to return the animal(s) upon demand will render the adopter liable to Whiskers-a-GoGo in the amount of \$500 to compensate the organization for veterinary and maintenance costs as well as costs and expenses incurred in connection with your breach of this agreement.*
